The itinerary for your upcoming sailing onboard Norwegian Dawn on November 24, 2023, has been modified due to the ongoing situation in Israel. Travel Partners are asked to share this information with impacted guests.

We are deeply saddened by this tragic situation and our thoughts are with all those impacted during this time. Your safety and that of our crew and the communities we visit is always our top priority. As such, we have made the difficult decision to cancel all calls to Israel for the remainder of 2023.
