Itinerary Change

Dear Valued Guests and Travel Partners,

The itinerary for your upcoming sailing on board Norwegian Dawn on January 3, 2024, has been modified. Travel Partners are asked to share this information with impacted guests.

As a proactive measure in response to recent developments in the region, we have canceled our calls to Fujairah, United Arab Emirates, Muscat, Oman, and Antsiranana, Madagascar. To accommodate this change, the ship will now call to Abu Dhabi, United Arab Emirates; Nosy Be, Madagascar; and add an additional day at sea. We understand that itinerary changes can be frustrating and sincerely apologize for any disappointment this may cause. While we share your disappointment, this modification was made with great consideration to preserve the guest experience while prioritizing your safety, and that of our crew. The revised itinerary follows:
