The itinerary for your upcoming vacation on board Norwegian Dawn on October 7, 2024 has changed. In addition, the ship will now depart from Barcelona, Spain at 4:30 p.m. local time. Travel Partners are asked to share this information with impacted guests.

Shore excursions booked through NCL for Koper, Slovenia and Zadar, Croatia will be automatically canceled, and a full monetary refund of the fare paid will be returned to the form of payment used at the time of reservation; no further action is required. Shore



excursions booked through NCL for all other ports will be automatically adjusted to coincide with the new times in port; no further action is required. Shore excursions for Dubrovnik and Split, Croatia will be available to book in two weeks.
