Itinerary Change

Dear Valued Guests and Travel Partners,

We have important information regarding your upcoming sailing on board Norwegian Dawn on March 20, 2024. Travel Partners are asked to share this information with impacted guests.

We pride ourselves on delivering incredible experiences, both aboard our ships and by taking our guests to some of the most sought-out destinations around the world. While we try to maintain original itineraries as much as possible, at times modifications are made to optimize the itinerary or to accommodate certain circumstances. As such, to remain compliant with global maritime regulations, we are required to adjust some of the original times in port as shown below. These regulations guided by the International Maritime Organization, are aimed to reduce the greenhouse gas emissions of ships, and align with our commitment to the environment and our sustainability efforts.

We recognize the importance that destinations play in our guests' vacation decision-making process and sincerely apologize for any inconvenience these adjustments may cause. As a sign of goodwill for these few changes to the time in port, we have arranged for a \$100 non-refundable onboard credit per stateroom. This will reflect as a \$50 non-refundable onboard credit for guest one and guest two on your onboard account. The modified itinerary is as follows:
