We have important information regarding Norwegian Dawn’s sailing on July 15, 2024. We ask Travel Partners to share this information with impacted guests.

We pride ourselves on delivering incredible experiences, both aboard our ships and by taking our guests to some of the most sought-out destinations around the world. While we try to maintain original itineraries as much as possible, at times we are required to make adjustments. In order to ensure a more immersive experience, which provides you with more time in port and less days at sea, we have revised the itinerary to now call to four new ports of call, including Berlin (Warnemunde), Germany; Gothenburg, Sweden; Kristiansand, Norway; and New Castle (Tyne), England. As such, we will no longer overnight in Hamburg, Germany. The revised itinerary is as follows:
