At Norwegian Cruise Line, we value your loyalty and thank you for making us your vacation of choice. We have important information regarding Norwegian Encore's 18-day sailing from Miami, FL on April 7, 2024. Travel partners are asked to share this information with impacted guests.

We are committed to delivering exceptional vacation experiences around the world. While it is always our intention to maintain original itineraries, at times unforeseen circumstances require us to make modifications. Due to port congestion expected in San Francisco, California, on April 25, 2024, the abovementioned itinerary has been modified from an 18-day to a 17-day voyage which will now end on April 24, 2024. WHAT HAPPENS NEXT:

All guests may choose one of the following options by Monday, May 15, 2023:

1) Sail on Norwegian Encore's modified 17-day itinerary and receive a 10% reduction of the original voyage fare paid as a result of the modification. If you have paid for your reservation in full, the adjustment will be refunded and processed within 30 business days to the original form of payment used at the time of booking. If you have not yet paid in full, the adjustment will be automatically applied to your reservation within 30 business days. If this is the preferred option, no further action is required.

OR

- 2) Cancel the current Norwegian Encore reservation and rebook at a later date. Guests who choose this option must contact us no later than Monday, May 15, 2023. In the U.S. and Canada, guests should call 1-800-327-7030, visit <u>www.ncl.com</u> or contact their travel advisor. Guests residing outside of the U.S. and Canada, should visit <u>www.ncl.com</u> for local contact information.
 - Upon cancelation, guests will receive a full refund that will automatically be returned to the original form of payment. The refund will be processed within 30 business days of cancelation and will be returned within seven to ten business days following the processed date. The visibility of the funds is dependent on the guest's financial institution's internal policies. If the current reservation was paid utilizing a Future Cruise Credit (FCC), 100% of the

FCC used will be re-applied to the guest's Latitudes account. No further action is required. The FCC(s) will be automatically returned by May 29, 2023.

Guests who do not contact us by Monday, May 15, 2023, will have their reservations moved to Norwegian Encore's 17-day itinerary shown above.

We truly appreciate your understanding and thank you for your continued loyalty. As such, all impacted guests will receive a 10% discount on their next cruise, combinable with all available promotions at the time of booking, regardless of the option selected. The 10% discount will be added to the guest's Latitudes account and will be available as of May 29, 2023. This discount can be applied towards sailings from May 29, 2023, through December 31, 2024.

SHORE EXCURSIONS

Shore excursions booked through NCL for San Francisco, CA will be automatically canceled, and a full monetary refund of the fare paid will be returned to the form of payment used at time of reservation; no further action is required. TRAVEL DOCUMENTS

Depending on nationality, guests may require a passport and/or a visa to visit certain ports of call. All necessary documentation should be printed and available to present at check-in on embarkation day. Guests who fail to obtain these documents will be denied boarding.
