**IMPORTANT INFORMATION**  
**Itinerary Change**

Dear Valued Guests and Travel Partners,

The disembarkation port for your upcoming sailing onboard Norwegian Epic on October 17, 2024, has changed to Piraeus (Athens), Greece due to the ongoing situation in Israel.

Please read this communication in its entirety. Travel Partners are asked to share this information with impacted guests.

As previously conveyed, we are deeply saddened by this tragic situation and our thoughts are with all those impacted during this time. As a proactive measure in response to recent developments in the region, Norwegian Epic’s itinerary has been modified. In addition to updating the debarkation port to Piraeus (Athens), Greece we will now include a call to Mykonos, Greece, and an additional day at sea.

We understand that itinerary changes can be frustrating and sincerely apologize for any disappointment this change may cause. While we share your disappointment, these modifications were made with great consideration to preserve the guest experience while prioritizing your safety, and that of our crew. The revised itinerary follows:

required. Shore excursions for Mykonos, Greece, will be available in 2 weeks.
