IMPORTANT INFORMATION Itinerary Change

Dear Valued Guests and Travel Partners,

At Norwegian Cruise Line, we value your loyalty and thank you for making us your vacation of choice. We have important information regarding Norwegian Epic's 9-day sailing from Civitavecchia, Italy on April 30, 2024. Travel partners are asked to share this information with impacted guests.

As a result of a fleet redeployment, the abovementioned itinerary has been extended from a 9-day to a 10-day voyage. The sailing will now depart on April 29, 2024, from Civitavecchia, Italy and include a transit through Messina Strait as well as a call to Piraeus (Athens), Greece. The revised itinerary is as follows:

All guests may choose one of the following options by Monday, April 24, 2023:

Sail on Norwegian Epic's new 10-day itinerary at no additional cost; that is an additional day to explore the ancient ruins and sunny beaches of the Mediterranean and Greek Isles for free! If this is the preferred option, no further action is required.

- 2) Cancel the current Norwegian Epic reservation and rebook at a later date. Guests who choose this option must contact us no later than Monday, April 24, 2023.  - Upon cancelation, guests will receive a full refund that will automatically be returned to the original form of
 payment. The refund will be processed within 30 business days of cancelation and will be returned within seven to
 ten business days following the processed date. The visibility of the funds is dependent on the guest's financial
 institution's internal policies. If the current reservation was paid utilizing a Future Cruise Credit (FCC), 100% of the
 FCC used will be re-applied to the guest's Latitudes account. No further action is required.

Guests who do not contact us by Monday, April 24, 2023, will have their reservations moved to Norwegian Epic's new 10-day itinerary.

We truly appreciate your understanding and thank you for your continued loyalty. As such, all impacted guests will receive a 10% discount on their next cruise, combinable with all available promotions at the time of booking, regardless of the option selected. The 10% discount will be added to the guest's Latitudes account and will be available as of May 12, 2023. This discount can be applied towards sailings from May 12, 2023, through December 31, 2024.

SHORE EXCURSIONS

Shore excursions booked through NCL for Santorini, Greece will be adjusted to coincide with new dates and times in port; no further action is required.
