Itinerary Change

Dear Valued Guests and Travel Partners,

The itinerary for your upcoming vacation on board Norwegian Epic on September 2, 2024, has changed. Travel Partners are asked to share this information with impacted guests.

We pride ourselves on delivering incredible experiences, both aboard our ships and by taking our guests to some of the most sought-out destinations around the world. While we try to maintain original itineraries as much as possible, unfortunately, at times modifications are made to optimize the itinerary or to accommodate certain circumstances. As such, due to updated port availability, we have adjusted the itinerary as shown below.

We recognize the importance of destinations in our guests' vacation decision-making process and assure you that this modification was made with an optimal guest experience top-of-mind. Although we will no longer be visiting Messina (Sicily), Italy, we are pleased to share that we have replaced the scheduled call with a visit to Catania, Italy. Catania, located on the eastern coast of Sicily, is home to Mount Etna, an active volcano, which just adds to this captivating city known for its natural beauty, historical depth, and a vibrant local culture. In addition, we have preserved the amount of time originally scheduled for our visit to Olympia (Katakolon), Greece. Shore excursions booked through Norwegian Cruise Line will remain unaffected, as excursions originally planned for Messina, Sicily, will now depart from Catania, Italy.
