IMPORTANT INFORMATION Itinerary Change

The itinerary for your upcoming sailing onboard Norwegian Gem on November 1, 2023, has been modified due to the ongoing situation in Israel. Travel Partners are asked to share this information with impacted guests.

We are deeply saddened by this tragic situation and our thoughts are with all those impacted during this time. Your safety and that of our crew and the communities we visit is always our top priority. As such, we have made the difficult decision to cancel all calls to Israel for the remainder of 2023. We understand that itinerary changes can be frustrating. We share your disappointment and regret that this situation has prevented us from delivering the vacation that both we and our guests imagined. As a genuine acknowledgment of the inconvenience caused and to thank you for your continued loyalty, we have arranged for a \$200 non-refundable onboard credit per stateroom. This will reflect as a \$100 non-refundable onboard credit for guest one and guest two on your onboard account.

SHORE EXCURSIONS

Shore excursions booked through NCL for Port Said (Cairo), Egypt, Jerusalem (Ashdod), and Tel-Aviv (Haifa), Israel, will be automatically canceled, and a full monetary refund of the fare paid will be issued to your onboard account; no further action is required. Shore excursions booked through NCL for Limassol, Cyprus, Alanya, Turkey, and Rhodes, Greece will be automatically adjusted to coincide with the new dates/times in port; no further action is required. Shore excursions for Alexandria, Egypt, Iraklion, Greece, and Mykonos, Greece will be available as soon as possible.
