The itinerary for your upcoming sailing onboard Norwegian Gem on November 22, 2023, has been modified due to the ongoing situation in Israel. Travel Partners are asked to share this information with impacted guests.

We are deeply saddened by this tragic situation and our thoughts are with all those impacted during this time. Your safety and that of our crew and the communities we visit is always our top priority. As such, we have made the difficult decision to cancel all calls to Israel for the remainder of 2023. We understand that itinerary changes can be frustrating. SHORE EXCURSIONS

Shore excursions booked through NCL for Rhodes, Greece, and Alanya, Turkey will be automatically adjusted to coincide with the new dates/times in port; no further action is required. Shore excursions booked through NCL for Jerusalem (Ashdod) and Tel-Aviv (Haifa), Israel, will be automatically canceled, and a full monetary refund of the fare paid will be returned to the form of payment used at the time of reservation; no further action is required. Shore excursions for Limassol, Cyprus, and Heraklion, Greece will be available in 2 weeks.
