IMPORTANT INFORMATION
Itinerary Change

Dear Valued Guests and Travel Partners,

Thank you for your loyalty and for making us your vacation of choice.

We have important information regarding Norwegian Gem’s sailing on August 4, 2023. We ask Travel Partners to share this information with impacted guests.

Due to the limited ability to sail into the Venice Lagoon and dock at the piers normally earmarked for large cruise ships, cruise ships calling to Venice are now required to anchor outside of the lagoon and utilize tender boats to access the Port of Venice. As a result, we had previously modified the itineraries for Norwegian Gem to tender guests to Venice.

While we have made every effort possible to maintain calls to Venice, the tender operations and overall experience this provided our guests has fallen short of the standard we aim to deliver. As a result, our call to Venice will be replaced with a call to Trieste, Italy. Additionally, complimentary transportation will be available from Trieste to Venice for guests who wish to spend their day exploring this magical city. We apologize for any inconvenience this change may cause; however, we hope you will continue to enjoy the incredible destinations you will enjoy during your voyage. Please note, while you may take the extended time in Trieste to explore the city, all guests must check-in and embark on August 8, 2023. The revised itinerary is as follows:
