#### **Itinerary Change**

Dear Valued Guests and Travel Partners,

We're excited to welcome you aboard for your upcoming cruise with Norwegian Cruise Line. To help you prepare for a seamless start to your August 24, 2026, voyage on Norwegian Getaway, we're sharing an update regarding your embarkation day experience in Miami. Travel partners are kindly asked to ensure impacted guests review the details below.

As part of PortMiami's continued efforts to enhance its sustainability initiatives, Norwegian Getaway will participate in the commissioning of the shore power system. This technology allows ships to connect to the local electrical grid while in port, reducing emissions and supporting a cleaner environment.

To accommodate this work, Norwegian Getaway will remain in Miami overnight before setting sail. As part of the commissioning activities, only one gangway will be available for guest access, and our team will be on hand throughout embarkation day to help ensure a smooth boarding experience. Guests should plan to arrive at the terminal during their assigned check-in time, which remains unchanged. While the ship will stay alongside in Miami until approximately 3:00 am, guests who board the ship will not be able to disembark later that evening.

While the timing of your voyage has been adjusted, all scheduled ports of call remain unchanged, and you'll still have plenty of time to enjoy the sun-soaked beaches, crystal-clear waters, and island experiences that await in the Bahamas. Your updated itinerary is below.
