We have important information regarding Norwegian Jewel's sailing on December 11, 2023. Travel Partners are asked to share this information with impacted guests.

We recently enhanced the original itinerary to include a port of call to Sihanoukville, Cambodia, however, given visa requirements, we have amended the itinerary to instead include a call to Ko Samui and Bangkok (Laem Chabang), Thailand.

Please note, guests who purchased a travel visa for Cambodia for this sailing are eligible to receive a non-refundable onboard credit valued at the cost of the visa when they submit a reimbursement request with the proof of purchase.
