We have important information regarding Norwegian Jewel's sailing on December 22, 2023. Travel Partners are asked to share this information with impacted guests.

We are committed to delivering exceptional vacation experiences around the world, including taking guests to some of the most bucket-list worthy destinations. We recently enhanced the original itinerary to include a port of call to Sihanoukville, Cambodia, however, given visa requirements, we have amended the itinerary to instead include an overnight call to Ho Chi Minh City (Phu My), Vietnam.

Please note, guests who purchased a travel visa for Cambodia for this sailing are eligible to receive a non-refundable onboard credit valued at the cost of the visa when they submit a reimbursement request with the proof of purchase.
