IMPORTANT INFORMATION Itinerary Change

Dear Valued Guests and Travel Partners,

At Norwegian Cruise Line, we value your loyalty and thank you for making us your vacation of choice. We have important information regarding Norwegian Sky's 16-day sailing from Haifa, Israel on November 18, 2024. Travel partners are asked to share this information with impacted guests.

We are committed to delivering exceptional vacation experiences around the world. While it is always our intention to maintain original itineraries, at times unforeseen circumstances require us to make modifications. Due to port congestion restricting the ability to embark in Haifa, Israel on November 18, 2024, the abovementioned itinerary has been modified from a 16-day to a 15-day voyage. The sailing will now embark in Haifa, Israel on November 19, 2024 and include an extended call to Jerusalem, Israel, allowing additional time to explore one of the most ancient cities in the world, as well as an extended cruise through the historic Suez Canal. We apologize for any inconvenience this may cause. The revised itinerary is as follows:

WHAT HAPPENS NEXT:

All guests may choose one of the following options by Monday, August 14, 2023:

1) Sail on Norwegian Sky's adjusted 15-day itinerary and receive a prorated refund of your original voyage fare paid, based on the reduced sailing length, as a result of this modification. All original promotions will be protected. If you have paid for your reservation in full, the prorated adjustment will be refunded and processed within 30 business days to the original form of payment used at the time of booking. If you have not yet paid in full, the adjustment will be automatically applied to your reservation within 30 business days. If this is the preferred option, no further action is required.

OR

2) Cancel your current Norwegian Sky reservation and rebook at a later date. Guests who choose this option must contact us no later than Monday, August 14, 2023. In the U.S. and Canada, guests should call 1-800-327-7030, visit www.ncl.com or contact their travel advisor. Guests residing outside of the U.S. and Canada, should visit www.ncl.com for local contact information.

• Upon cancelation, guests will receive a full refund that will automatically be returned to the original form of payment. The refund will be processed within 30 business days of cancelation and will be returned within seven to ten business days following the processed date. The visibility of the funds is dependent on the guest's financial institution's internal policies. If the current reservation was paid utilizing a Future Cruise Credit (FCC), 100% of the FCC used will be re-applied to the guest's Latitudes account approximately 7 days from the date of cancelation. No further action is required.

Guests with active reservations as of Tuesday, August 15, 2023, will have their reservations moved to Norwegian Sky's new 15-day itinerary.

TRAVEL DOCUMENTS

Depending on nationality, guests may require a passport and/or a visa to visit certain ports of call. All necessary documentation should be printed and available to present at check-in on embarkation day. Guests who fail to obtain these documents will be denied boarding. YOUR HEALTH AND SAFETY
