**IMPORTANT INFORMATION**  
**Itinerary Change**

Dear Valued Guests and Travel Partners,

Due to the ongoing situation in Israel, the disembarkation port for your upcoming sailing onboard Norwegian Sky on November 4, 2024, has changed from Haifa, Israel to Piraeus (Athens), Greece.

Please read this communication in its entirety, as it contains important information regarding your upcoming vacation. Travel Partners are asked to share this information with impacted guests.

As previously conveyed, we are deeply saddened by this tragic situation and our thoughts are with all those impacted during this time. As a proactive measure in response to recent developments in the region, Norwegian Sky's itinerary has been modified. In addition to updating the disembarkation port to Piraeus (Athens), Greece, we will now include a call to Mykonos, Greece, an overnight call to Alexandria, Egypt; affording you an additional day to explore this fascinating city and an additional day at sea.

We understand that itinerary changes can be frustrating and sincerely apologize for any disappointment this change may cause. While we share your disappointment, these modifications were made with great consideration to preserve the guest experience while prioritizing your safety, and that of our crew. The revised itinerary follows:

Shore excursions booked through NCL for Piraeus (Athens), Greece, Port Said (Cairo), Egypt, and Ashdod, Israel will be automatically canceled, and a full monetary refund of the fare paid will be returned to the form of payment used at the time of reservation; no further action is required. Shore excursions for Mykonos, Greece will be available in two weeks. **TRAVEL DOCUMENTS**
