The itinerary for your upcoming vacation on board Norwegian Star on May 30, 2024 has changed. Travel Partners are asked to share this information with impacted guests.

Shore excursions booked through NCL for Akureyri and Isafjordur, Iceland; Honningsvag, Norway, on June 7, 2024; and Alta, Norway, on June 9, 2024, will be automatically adjusted to coincide with the new dates/times in port. No further action is required. Shore excursions for Seydisfjordur, Iceland and Tromso, Norway will be available to book in two weeks. If you are
