Itinerary Change

We have an important update to your upcoming cruise aboard Norwegian Star, sailing on September 27, 2026. Following a change in Norwegian Star's scheduled dry dock for technical enhancements, your sailing has been extended from seven days to ten days, giving you more time to relax and explore even more incredible destinations. Travel partners are asked to please ensure that impacted guests review this information.

As part of this change, the itinerary has been adjusted. While we will no longer visit Oporto, Portugal, we are pleased to announce the addition of four new ports. In France, La Rochelle offers a charming mix of coastal beauty and historic architecture, while Le Verdon-sur-Mer provides easy access to the world-famous Bordeaux wine region. In Spain, Bilbao showcases vibrant Basque culture and modern attractions like the Guggenheim Museum, and Vigo is known for its fresh seafood, beaches, and nearby Cíes Islands. Additionally, the date of our scheduled visit to La Coruña, Spain, has been adjusted.

This new ten-day itinerary provides three extra days to enjoy these exciting destinations at no additional cost.
