We have important information regarding Norwegian Sun’s sailing on October 30, 2023. We ask Travel Partners to share this information with impacted guests.

While we try to maintain original itineraries as much as possible, unfortunately, at times there are circumstances outside our control that require us to make adjustments. As such, due to recent local government regulations in Monterey, California closing the destination to cruise tourism, as well as our efforts to remain compliant to voluntary whale zone speed restrictions in the area, the itinerary has been revised as follows:
