Itinerary Change

Dear Valued Guests and Travel Partners,

The itinerary for your upcoming vacation on board Norwegian Viva on October 9, 2025 has changed. Travel Partners are asked to share this information with impacted guests.

We have been monitoring the situation in Israel, and despite our best hopes that it would de-escalate, we have made the decision to alter published itineraries that transit through and around the region. With this in mind, we have adjusted the original itinerary as shown below. We apologize for any inconvenience these adjustments may cause.

We recognize the importance that destinations play in our guests' vacation decision-making process and assure you that these modifications were made with an optimal guest experience top-of-mind. While we will no longer be calling on Alanya, Turkey; Tel-Aviv (Haifa) and Jerusalem (Ashdod), Israel, we are pleased to share that we have added a visit to Alexandria (Cairo), Egypt and Limassol, Cyprus.
