## IMPORTANT INFORMATION Voyage Cancelation

Dear Valued Guests and Travel Partners,

We are committed to providing exceptional vacation experiences, both aboard our ships and by taking our guests to some of the most sought-out destinations around the world. While we try to maintain original itineraries as much as possible, at times modifications are made to optimize voyages to meet guest demand or due to changing port availability.

From November 2026 to March 2027, Norwegian Dawn and Norwegian Gem will swap homeports. Norwegian Dawn will be redeployed to Jacksonville, Fla. and Norwegian Gem to Tampa, Fla. where they will sail new enhanced itineraries. These new voyages will offer a wider variety of options, including more calls to Great Stirrup Cay, our private island in the Bahamas, giving guests more opportunities to enjoy the brand-new experiences transforming the island in 2026.

As part of this redeployment, Norwegian Dawn's sailings from November 1, 2026 through and including December 27, 2026 have been canceled and will be replaced with a new itinerary that will go on sale soon. Travel partners are kindly asked to ensure that impacted clients review this information.

Now, let's talk about what happens next, here's everything you need to know:

A full monetary refund of the fare paid for the canceled cruise will be automatically returned to the original form of payment used at the time of reservation. Refunds will be automatically processed within 30 business days, and funds should appear within seven to 10 business days after processing, depending on each financial institution's internal policies. If your reservation was paid with a previously issued Future Cruise Credit (FCC), 100% of the FCC used will be automatically re-applied to your Latitudes account within 10 days of the cancelation date. No further action is required.

We know this change wasn't part of your original plans, and we're grateful for your understanding. To thank you, we're extending a 10% discount in the form of a FCC, which can be applied to any of our published sailings through December 31, 2026. The credit will be available starting October 6, 2025, and we hope it brings you one step closer to your next unforgettable journey with us.

Our team is working diligently to open new sailings for these dates that will be available to book in the near future. In the meantime, if you're still dreaming of that perfect getaway, we have some fantastic alternative sailings with the same itinerary:
