Voyage Cancellation

Norwegian Encore's sailings from December 14, 2025, through and including January 11, 2026, have been canceled as a result of a fleet redeployment. We sincerely apologize for any inconvenience this may cause. Travel Partners are asked to share this information with impacted guests.

At Norwegian Cruise Line, we strive to create extraordinary vacation experiences that delight our guests. Occasionally, scheduled itineraries may need to be canceled, allowing us the opportunity to introduce enhanced voyages that accommodate strong guest demand and provide a more immersive experience. While unfortunately cancellations may arise, please rest assured that we are always working hard to provide you with world-class cruise vacations to bucket-list destinations. We sincerely apologize for any inconvenience or disappointment this cancellation may cause.

Norwegian Encore will be redeployed and will soon offer 7-day itineraries, sailing round-trip from Miami to the Western Caribbean, featuring a perfect blend of exotic island adventures and rich cultural experiences. These new itineraries will be available to book soon.

A full monetary refund of the fare paid for the canceled cruise will be automatically returned to the original form of payment provided at the time of reservation. No further action is required; the refund will be automatically processed within 30 business days. You will see the refund returned to the original form of payment seven to 10 business days from the processed date. The visibility of the funds is dependent on each financial institution's internal policies.

For those reservations paid via a previously issued Future Cruise Credit (FCC), 100% of the FCC used will be automatically re-applied to your Latitudes account within 10 days of the cancellation date. No further action is required.

As a genuine acknowledgement of the inconvenience caused, we will be extending a 10% discount in the form of a FCC to be used towards any of our published sailings through December 31, 2026. The FCC will be available for use beginning on December 16, 2024.
