**Itinerary Change** 

Dear Valued Guests and Travel Partners,

We've made an update to your itinerary for your upcoming Norwegian Epic cruise setting sail on April 19, 2026. In addition, the departure time from San Juan, Puerto Rico, has been adjusted from 7:00 p.m. to 4:00 p.m. Travel partners are asked to please ensure that impacted guests review this information.

We know a lot goes into planning the perfect vacation: countless dreams of ocean breezes, way too many shoes packed "just in case," and a countdown clock that's getting harder to ignore. So when we make an itinerary change, it's never just a line on a map. It's something we think about carefully, always with your experience at the heart of it. In addition, our time in port for the visit to Ibiza, Spain has been adjusted to align with the ferry schedule and ensure a smooth tendering experience. These changes are often beyond our control, and as passionate cruisers ourselves, we truly understand how disappointing they can be.

The good news? We've added a visit to Cartagena, Spain, a historic coastal city known for its Roman ruins, charming old town, and beautiful harbor views. Your updated itinerary is below.
