The itinerary for your upcoming vacation on board Norwegian Joy on January 5, 2025, has changed. Travel Partners are asked to share this information with impacted guests.

Additionally, we have added a visit to Mazatlan, Mexico, Puerto Caldera (Puntarenas), Costa Rica, and Colon, Panama. From surfing and snorkeling to deep-sea fishing and golf, Mazatlán offers a wide range of outdoor adventures for all interests. Shore Excursions for Mazatlan, Mexico, Puerto Caldera (Puntarenas), Costa Rica, and Colon, Panama, will be available to book in three weeks.
