Voyage Cancellation

Dear Valued Guests and Travel Partners,

As we look ahead to Winter 2027–2028, we're excited to expand the variety of Caribbean experiences available across our fleet. As such, we will be modifying Norwegian Joy's current deployment. While still sailing from Miami, she will offer a new lineup of longer, more immersive Caribbean itineraries, including 9 and 10-day Southern Caribbean sailings, along with select 3 and 4-day Bahamas getaways in between. These thoughtfully designed voyages offer a broader range of destinations and more time to enjoy the places guests love most. As a result of this new update, the January 10, 2028, voyage aboard Norwegian Joy, will no longer operate as planned and has been canceled. Travel partners are kindly asked to ensure impacted guests review this information.

While we know changes to travel plans can come as a surprise, they also give us the opportunity to offer voyages that bring even more of the Caribbean into each journey. Norwegian Joy's new Caribbean itineraries, featuring even more variety and discovery, will be available to book soon.

For reservations paid using a previously issued Future Cruise Credit (FCC), 100% of the FCC applied will be automatically reissued to your Latitudes account within 10 days of the cancellation date. No further action is required.

***Future Cruise Credit (FCC)***

We recognize this change wasn't part of your original travel arrangements, and as a token of our appreciation for your patience, we are pleased to offer a 10% Future Cruise Credit, valid toward any published sailing through December 31, 2028. This credit will be available beginning June 8, 2026, and we hope it helps bring you closer to your next unforgettable journey with us.
