

IMPORTANT INFORMATION Voyage Change

Dear Valued Guests and Travel Partners,

The itinerary for your upcoming vacation on board Norwegian Sky on March 13, 2025, has changed from a 16-day to a 15-day voyage, and will now embark in Incheon, South Korea, on March 14, 2025. Travel partners are asked to share this information with impacted guests.

While it is always our intention to maintain original itineraries, at times unforeseen circumstances require us to make modifications. Due to limited port availability preventing us from embarking in Incheon, South Korea, on March 13, 2025, we will now embark in Incheon on March 14, 2025. In addition, while we will no longer visit Jeju (Jeju Island), South Korea, and Ishigaki, Japan, we are pleased to share that we will now include a call to Naha, Japan, allowing you to explore the scenic countryside, WWII memorials, magnificent limestone caves and so much more! As a result of this modification, all guests will receive a prorated refund of the original voyage fare paid, based on the reduced sailing length. All original promotions will be protected. If you have paid for your reservation in full, the prorated adjustment will be refunded and processed within 30 business days, to the original form of payment, used at the time of booking. If you have not yet paid in full, the adjustment will be automatically applied to your reservation within 30 business days.

As a gesture of appreciation for choosing to sail with us, and to thank you for your continued loyalty, we will be extending a 10% discount in the form of an FCC (Future Cruise Credit) to be used towards any of our published sailings through December 31, 2025. The FCC will be available for use beginning on Wednesday, July 10, 2024.

SHORE EXCURSIONS

Shore excursions booked through NCL for Jeju (Jeju Island), South Korea, and Ishigaki, Japan, will be automatically canceled, and a full monetary refund of the fare paid will be returned to the form of payment used at the time of reservation; no further action is required. Shore excursions booked through NCL for Keelung, Taiwan, will be automatically adjusted to coincide with the new times in port; no further action is required. If we are unable to make the necessary adjustments, impacted shore excursions will be automatically canceled, and a full monetary refund of the fare paid will be issued to your onboard account; no further action is required. Shore excursions for Naha, Japan, will be available to book in three weeks.
