**Itinerary Change** 

Dear Valued Guests and Travel Partners,

We've made an update to your itinerary for your upcoming Norwegian Spirit cruise setting sail on October 19, 2025. Travel partners are asked to please ensure that impacted guests review this information.

In Sakaiminato, manga magic meets maritime heritage, where whimsical yokai statues, vibrant fish markets, and nearby treasures like Matsue Castle and Izumo-Taisha Shrine await. These two ports bring a delightful mix of seafood indulgence, cultural immersion, and unique local flair, perfect for enriching your cruise experience through coastal Japan.
