Required Travel Documentation

A passport, visa, and/or other documentation may be required for your cruise, depending on your nationality and itinerary. If traveling internationally, the countries you are transiting through to join your cruise may also have additional mandatory travel requirements. Printed travel documents must be presented at check-in on embarkation day. As it is your responsibility to secure all



necessary documentation, any guest arriving without meeting the proper travel requirements or documentation may be denied boarding at embarkation.
