Itinerary Change

Dear Valued Guests and Travel Partners,

We've made an update to your itinerary for your upcoming Norwegian Sun cruise setting sail on August 29, 2026. Travel partners are asked to please ensure that impacted guests review this information.

We know planning a vacation is practically a full-time job with researching, planning, and cramming everything you *might* need into a suitcase that barely zips. With that in mind, we want to let you know that, due to updated port availability, our visits to Klaipeda, Lithuania, and Gdynia (Gdansk), Poland, have been canceled. The good news? We've added a visit to Riga, Latvia. Similar to Klaipeda, and Gdynia, Riga offers rich history, vibrant culture, and plenty of opportunities to explore, ensuring you'll have a wonderful experience ashore.

Additionally, we've adjusted the timing of our scheduled visit to Kiel, Germany. This change will allow us to arrive in Copenhagen, Denmark a bit earlier, which will help make your disembarkation experience as smooth and comfortable as possible. Your updated itinerary is listed below.
