Dear Valued Guests and Travel Partners,

We're excited to welcome you aboard Norwegian Sun for your upcoming cruise departing September 23, 2026. As we prepare for your voyage, we'd like to share an update to your itinerary. Travel partners are asked to please ensure that impacted guests review this information.

Even the most thoughtfully planned voyages may occasionally evolve. While we always strive to operate each sailing as planned, there are times when adjustments are necessary. To support required maintenance, which does not affect the safety of our ship or that of our guests and crew, our highest priority, our visit to **Oslo, Norway**, and one scheduled day at sea have been replaced with **two overnight stays in Copenhagen, Denmark**. While we understand many guests were looking forward to visiting Oslo, this additional time in Copenhagen offers greater flexibility to explore one of Scandinavia's most beloved capitals, from its historic landmarks and waterfront charm to its renowned culinary scene and vibrant local culture.

Please note that although the ship will remain in Copenhagen overnight, guests are still required to arrive at the terminal during the designated arrival window selected during Online Check-In. To help ensure a smooth embarkation experience for all guests, pre-selected arrival times will be strictly enforced, and guests arriving before their assigned time will not be permitted early entry.

We sincerely appreciate your understanding and flexibility as we complete this necessary maintenance. As a gesture of our appreciation, each stateroom will receive a **\$100 non-refundable onboard credit**, provided as **\$50 onboard credit for guest one and guest two**, which will be automatically applied to your onboard account. REQUIRED TRAVEL DOCUMENTATION

A passport, visa, and/or other documentation may be required for your cruise, depending on your nationality and itinerary.
