If we are unable to make the necessary adjustments, impacted shore excursions will be automatically canceled, and a full monetary refund of the fare paid will be returned to the form of payment used at the time of reservation; no further action is required. Shore excursions for Motril, Spain, will be available to book in three weeks. REQUIRED TRAVEL DOCUMENTATION
