The itinerary for your upcoming vacation on board Norwegian Viva on June 26, 2025, has changed. In addition, the arrival time in Piraeus (Athens), Greece, is now scheduled for 6:00 a.m. local time. Travel Partners are asked to share this information with impacted guests.

Additionally, our planned stop in İzmir (Ephesus), Turkey, has been updated to dock in Kuşadası, Turkey. Located closer to the ancient city of Ephesus, Kuşadası offers convenient access to renowned archaeological sites such as the Library of Celsus and the Grand Theater. In addition to its historical significance, Kuşadası features a lively waterfront, bustling bazaars, and a charming atmosphere, making it a wonderful gateway to the region's rich cultural heritage.
