The itinerary for your upcoming vacation on board Norwegian Viva on July 27, 2025, has changed. In addition, the arrival time in Piraeus (Athens), Greece, is now scheduled for 6:00 a.m. local time. Travel Partners are asked to share this information with impacted guests.

If we are unable to make the necessary adjustments, impacted shore excursions will be automatically canceled, and a full monetary refund of the fare paid will be returned to the form of payment used at the time of reservation; no further action is required. Shore excursions for Volos, Greece, will be available to book in three weeks. REQUIRED TRAVEL DOCUMENTATION
