Itinerary Change

The itinerary for your upcoming vacation on board Norwegian Viva on August 10, 2025, has changed. In addition, the arrival time in Piraeus (Athens), Greece, is now scheduled for 6:00 a.m. local time. Travel Partners are asked to share this information with impacted guests.

Additionally, our time in Bodrum, Turkey, has been extended.

REQUIRED TRAVEL DOCUMENTATION
