

IMPORTANT INFORMATION Itinerary Change

The itinerary for your upcoming vacation on board Norwegian Viva on September 11, 2025, has changed. In addition, the arrival time in Piraeus (Athens), Greece, is now scheduled for 6:00 a.m. local time. Travel Partners are asked to share this information with impacted guests.

Volos offers guests a unique blend of history, culture, and natural beauty, with highlights like the breathtaking Meteora Monasteries, the scenic villages of Pelion Mountain, and the charming waterfront lined with local tavernas and cafés. While in Kusadasi, guests can enjoy exploring the ancient ruins of Ephesus, shopping in the vibrant Kusadasi Bazaar, relaxing on its beautiful beaches, and enjoying traditional Turkish cuisine, all while soaking in the lively atmosphere of this charming coastal town.

Additionally, we have extended our visit in Mykonos, Greece, famous for its narrow, winding streets lined with whitewashed buildings, boutique shops, and lively cafes. The revised itinerary is below:

If we are unable to make the necessary adjustments, impacted shore excursions will be automatically canceled, and a full monetary refund of the fare paid will be returned to the form of payment used at the time of reservation; no further action is required. Shore excursions for Volos, Greece, and Kusadasi, Turkey, will be available to book in three weeks. REQUIRED TRAVEL DOCUMENTATION

As it is your responsibility to secure all necessary documentation, any guest arriving without meeting the proper travel requirements or documentation may be denied boarding at embarkation.
