The itinerary for your upcoming vacation on board Norwegian Viva on September 2, 2025, has changed. In addition, the arrival time in Piraeus (Athens), Greece, is now scheduled for 6:00 a.m. local time. Travel Partners are asked to share this information with impacted guests.
