IMPORTANT INFORMATION **Itinerary Change**

Dear Valued Guests and Travel Partners,

We're excited to welcome you aboard Norwegian Viva for your upcoming cruise departing May 8, 2026. As we finalize plans for your sailing, we've made an itinerary adjustment due to updated port availability. We've also revised the embarkation time to better support guests' flight planning. Travel partners are asked to please ensure impacted guests review the details below.

Even the most carefully planned itineraries can occasionally change. When they do, we see them as an opportunity to thoughtfully reshape the journey, while still delivering the experience you're looking forward to. Although we work closely with port authorities to secure every detail well in advance, availability can shift, sometimes with little notice. These changes are beyond our control, and as fellow travelers, we understand how disappointing they can be.

As a result, we will no longer be calling on Dubrovnik, Croatia. In its place, we're pleased to add Zadar, Croatia, an Adriatic gem known for its historic streets, crystal-clear waters, and memorable seaside views. We've also adjusted our port times in Kotor, Montenegro. Your revised itinerary appears below.

REQUIRED TRAVEL DOCUMENTATION

As it is your responsibility to secure all necessary documentation, any guest arriving without meeting the proper travel requirements or documentation may be denied boarding at embarkation.
