We're looking forward to welcoming you aboard the beautiful Norwegian Viva for your voyage departing June 4, 2027. As you prepare for your journey, and as part of our commitment to delivering a seamless, memorable experience, we'd like to share an update to your thoughtfully planned itinerary. Travel partners, please ensure any impacted guests have the opportunity to review the details below.

While every voyage is carefully designed, occasional adjustments allow us to deliver the smoothest and most enjoyable experience possible. Due to limited availability of essential port services in Kotor, Montenegro, we've made the decision to remove this call to ensure a more seamless day ashore and an overall better guest experience. In its place, we're pleased to introduce Bar, Montenegro. Similar to Kotor, Bar offers a rich sense of history set against dramatic coastal scenery, with walkable areas, ancient ruins, a lively waterfront, and easy access to Montenegro's natural beauty, creating a relaxed and rewarding way to experience the Adriatic coast.

Additionally, due to revised port availability, our scheduled visits to Cannes, France, and Messina, Italy, have been replaced with visits to Nice (Villefranche), France, and Catania, Italy, and we've extended our visit to Civitavecchia (Rome), Italy. While guests will no longer visit Cannes and Messina, these updated ports offer equally captivating opportunities to experience the Mediterranean. Nice (Villefranche) serves as a stunning gateway to the French Riviera, where picturesque seaside villages, elegant promenades, and world-renowned coastal views await. In Sicily, Catania offers a vibrant blend of history, culture, and local flavor, with the iconic Mount Etna providing a dramatic backdrop to the city. Your updated itinerary is outlined below.
